## MEMBERSHIP OF KOROIT MEN'S SHED INC.

As a member of the KMS, I have read the rules of the shed and agree to accept these rules and those of the Australian Men's Shed Association that are in force during my period of membership. I understand that if I do not abide by these rules I may be asked to leave the shed.

### Rules of Koroit Men's Shed

- a. Members must sign in the Attendance book whenever they enter the shed. Any injuries or problems with machines or other issues should also be noted in this book.
- b. Only members who have been shown correct use procedures are able to use power equipment.
- c. Machinery must not be operated while under the influence of drugs, alcohol or medication.
- d. Appropriate eye and ear protection and when necessary hair covers and dust masks must be used when operating machinery or using volatile substances or sanding equipment.
  - Protective equipment must also be used by spectators/helpers in close proximity to machines.
- e. Members working alone in the shed are NOT covered by the Shed Insurance policy and so work at their own risk. Power tools can only be used when at least 2 members are present.
- f. Guards on machinery must not be removed.
- g. Saw benches or other machinery is not to be used as general work areas.
- h. Any material that contains or has been in contact with asbestos or other hazardous materials or contains hazardous chemicals, eg lead based paint is not to be brought to the shed.
- i. Treated pine timber (CCA) must be kept in the external wood store and only cut or machined outside the shed.
- j. No treated or painted timber, plastic or other material is to be burnt in the wood heater.
- k. Cooking in the workshop is not to occur while machinery is in operation.
- l. Food containers, crockery not to be used for storing, handling chemicals, paint, glue etc.
- m. Equipment may only be borrowed from the shed with permission of a member of the Committee and recording details in the Day book.
